- 4. I waive all claims against any of the Released Parties for any injuries, damages, losses or claims, whether known or unknown, which arise during or result from my participation in Service, regardless of whether or not caused in whole or part by the negligence, carelessness, recklessness, or other fault of any of the Released Parties. I release and forever discharge the Released Parties from all such claims.
- 5. I agree to indemnify and hold the Released Parties harmless for all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that may be brought against any of the Released Parties which arise during or result from my participation in Service, regardless of whether or not caused in whole or part by the negligence, carelessness, recklessness, or other fault of any of the Released Parties.
