SEQR Type II Determination (DPW and Fire Hall Improvements)
Trustee offered the following resolutions are moved for its adoption:
WHEREAS, the Village of Depew (Village) is considering various capital improvements at the local Fire Halls and Village DPW property. Improvements include replacement of the roof systems at 45 Meridian Street and 112 Brewster Street; concrete driveway pad replacements at 2325 George Urban Boulevard, 45 Meridian Street, and 112 Brewster Street; and replacement of a back-up power generator, in kind, at the Depew DPW, and boiler replacement at 112 Brewster Street.
WHEREAS , after comparing the thresholds in 6 NYCRR 617.4 and 617.5 under SEQR, the Village has determined that the proposed improvements meet the definition of a Type 2 action involving the maintenance, repair and replacement of existing facilities involving no substantial changes to existing facilities.
NOW THEREFORE BE IT RESOLVED , that as a Type 2 action under SEQR, the project has been found categorically to not have significant adverse impacts on the environment and no further review under SEQR is required.
