## **DEPARTMENT HEAD REPORTS**

#### **PUBLIC COMMENTS:**

Mayor Peterson: Fireman's Park is changing in nature we've had this discussion with our Rec Director I think a lot of as we move forward with the improvements there the staffing has to change a little bit because the park is being used so much I think it's important that most times if somebody's using our park system there can look up and see somebody in

an appropriate shirt that says Recreation Department staff especially with the new Pavilion being used I'm just going to get on a soap box for a little bit we had an issue last week with uh some young kids in the bathrooms and you know we can't see but just the hallway through the camera system and so I mean I could tell there are younger kids they're probably seven and eight year olds and so there was some mischief is going on with water and luckily there's nothing done to the walls or any of the fixtures and so forth. We spent a lot of money there was a lot of effort to put into that so we don't want to really have to turn the bathrooms off since that was the whole idea of putting in new bathrooms is that you could you know actually use a toilet or a urinal instead of some other primitive method of going to the bathroom so we adjusted the times a little bit Regina adjusted the times a little bit trying to take into consideration when there be most people in the park so that there is bathroom facilities. But we really don't want to have to do anything about you know closing them down and all so if you're happen to be out there and you know stop by and be in the adult age you might be you know just pass along that they shouldn't be doing anything respect that that property okay.

Elizabeth Brinkworth, Assemblymember Monica Wallace's Office: Busy couple of weeks, lots of bills. Assemblymember Wallace's ERPO 7717 Bill, issue with risk potential orders, takes the officer's names off and puts the agency's name on of any civil lawsuits, passed both the Assembly and Senate. Bill was pushed on behalf of local PBA's across the State of New York as well as the investigators unit, hopeful that in the coming months, the Governor will sign the bill. Assemblymember Wallace toured Union East Elementary in Cheektowaga, were invited to read a book to the children. Assemblymember Wallace announced half of a million dollars to PUNT, a local non profit that does a lot of great work for children who are going through pediatric cancer and their families. Very busy in Albany and quite the summer calendar booked.

Mayor Peterson: Received a call from Assemblymember Wallace that she got us another \$10,000 which will go towards our events in the Village.

Chief McNamara: Was fortunate enough to receive a call from Assemblymember Wallace for \$20,000 grant.

Mayor Peterson: Senator Kennedy before he became Congressman Kennedy also helped us out with \$51000.

Ken Pyc, DPW Superintendent: They are cutting high grass areas and will begin milling & paving the week of July 8<sup>th</sup>.

Kevin Ferguson, Recreation Director: Everything in full swing going at the park, the second softball league starts this Friday, we have volleyball, kickball going on right now. Floor hockey is still going on but I had to suspend it because we got our sport court in and the guys are putting it in this week, so should be all set to go. Reached out to the hockey teams in the WNY area to come in and for practices and stuff to rent out the rink.

Don Bielefeld: Code Enforcement: Put out a lot of violation letters, getting a lot of calls about tall grass. Summer help will reach out and clean. Keep your grass cut and clean along the fence line and garage. Hiring a PT Code Enforcement Officer to help out with needs.

Chief Musielak, Fire Department: 18 calls since last meeting, 161 year to date. Thanks to DPW and Superintendent Pyc on the maintenance on the buildings, they are great with that. Losing a great asset in Ron, leaving big shoes to fill. And use common sense when grilling or with small campfires. Make sure following laws just be safe.

Chief McNamara, Police Department: Police department responded to 1,213 complaints, 107 criminal, 1016 non-criminal, had 3 stolen vehicles, one was recovered in the City of Buffalo. 43 accidents, 3 with injury, 40 property damage only, arrested 35 subjects for criminal offences, 24 males, 11 females, 360 tickets issued for the month of May and 17 parking tags.

Sam Alba, Village Attorney: Welcome to our guest observing government working. The long environmental quality review was because of a law that says a municipality has to read through the entire thing and basically say our construction project is not going to do

anything to the environment. There is another version when it will do something to the environment, there are different reports. Nothing much to report.

Trustee Hamernik: Received funds from Chick-Filet for Community Center which was very nice and hoping to have a speculative date coming up pending the certificate of occupancy. Wanted to introduce daughter who is in from Michigan.

Trustee Ziemba: We had our preparation meeting for the Home Hazardous Waste event that the Village will be hosting on July 13, it was attended by both Chiefs and we have a plan in place. Residents, you have to log on to the website starting June 13 to make an appointment if you want to drop anything off, go to the county website at erie.gov/recycling to make your appointment – will tell you where it will be and they will send a map how to travel there. Happy Father's Day to all our fathers, grandfathers, godfathers and father figures in the Village.

Trustee Kraft: Past week got donations for the Family Friendly Zone for Founders' Day so far, Horizon Masonry Restoration, JDM Construction and CS Behler.

Deputy Mayor Adolf: Reiterate that concerts start on Thursday, June 20<sup>th</sup> with the Yachtfathers, so spread the word.
