#### Public Hearing - Cannabis Dispensaries

The public hearing was opened at 7:21 PM by Trustee Hamernik & Deputy Mayor Adolf

Dave Burkhardt, 5 AutumnLea: Questioned whether the special use permit would be renewable every year.

Village Attorney Alba explained it would the special use permit would be valid for a period of two years.

Charlene Wilbur, 222 Darwin Dr: Questioned whether the Village took into consideration how close a retail shop would be to where children would be attending. Had concerns because of a cannabis shop near PJ Cools.

Village Attorney Alba explained cannabis shops need to go to Planning Board and they can hear testimony from neighbors about their concerns but they are no rules from New York State that they cannot be near an ice cream shop or a toy store.

Mr. Thomas Spanos explained that every retail cannabis business that will be get licensed by the State has to notify their local municipality, and if the municipality objects when someone goes to apply, the state has been respecting that right now in terms of their decisions.

Paul Sprada, 58 Argus Drive: Had a question on how the distance requirements are measured – whether door to door or property line. Has a concern about the smoke shop near the Cantalician Center. Wondered about the need for a sprinkler system in these shops.

Mr. Michael Ortiz, Herbal Iq, 6061 Transit Rd: Explained they are provisionally licensed by the state, discussed their business, an adult recreational use dispensary.

Trustee Ziemba questioned if they have put an application in in North Collins.

Mr. Ortiz explained that Town of North Collins opted out but the Village of North Collins opted in and they are in talks there.

Deputy Mayor Adolf asked if the Depew location is their flagship store.

WHEREAS, Currently, the two members of the OEM have developed a very strong bond and passion to assist in the overall protection of the residents and businesses of the Village of Depew by being involved in the development of Incident Action Plans (IAP) for such Village events such as the Summer Concerts, Founder's Day Celebration, the Annual Tree Lighting Ceremony, the Joint Veterans Memorial Day Parade, the answering of all Emergency Calls regarding the BNIA, the recent COVID Health crisis, the recent Blizzard, Snow Storms and

Electrical outages among other Village, Town, County or State emergencies; and

WHEREAS, Over the past four years the OEM has been working closely with the Depew Police Department and by having them be aligned and under their "umbrella" would make for a more cohesive arrangement: and

NOW, THEREFORE, The Board of Trustees of the Village of Depew wishes to go forward with this alignment of OEM and Police Department beginning June 13<sup>th</sup>,2023 until the first Monday in April 2024, at which time the arrangement will be evaluated and determined if this arrangement will continue.
