#### **DEPARTMENT HEAD REPORTS –**

Don Bielefeld, Code Enforcement: Reminded residents to keep grass cut, and foundations, fence lines cleaned up. Huge issue still with unregistered vehicles. Working on getting final grading and hydroseeding on 73 Main Street. Hidden Shamrock cleaned up backside of building and put on new roof.

Ken Pyc, DPW: Did some blacktop work on West Dawson Playground to make it easier to park, waiting for dirt to settle for the geothermal. Calls about 39 Columbia, about possibly some poison hemlock and looking at way to rectify and point them in right direction.

Mayor Peterson: Hemlock is not on Village property, OEM is going to contact DEC for suggestions. Major changes to the Pavilion this week, roof is going on, dormer is up and they are putting the stone up this week. As it was mentioned, concerts start this week, have 8 great shows, every sponsor from last year came back and added a few new ones. Fire Department will be there, they have been a Gold sponsor from the start, a number of Gold Sponsors, Greg's Tree Service comes to mind. Diamond Sponsor is Casey's and Twin Village Recycling. It's a fun, family type outing, food trucks on site from 5:30 on.

Kevin Ferguson: Pool opened yesterday, have 15 lifeguards on staff.

Chief Gauthier, Fire Department: Summer Concert series starting this Thursday, the Fire Department will be out there assisting the Village with the festivities, Founders' Day also the Fire Department will be out there, if anyone is looking to join, visit website at DepewFire.org, fill out the suggestion area under recruitment and they will be in touch. For the month of June, 29 calls and 179 year to date.

Captain Curr, Police Department: New academy starts July 31, hoping to have 3 recruits, there were a couple of smash and grabs, Outlet Liquor and Speedway by Patrick, just want people to be on the lookout, throughout the County these are on the increase, ask residents if you see anything suspicious, if you see something, say something, give us a call and hopefully we can prevent more of these from happening in the future.

Sam Alba, Village Attorney: Busy week, meeting on a legal matter in Executive Session, we have a Red Flag Law hearing coming up.

Trustee Ziemba: Wanted to remind residents of the Home Hazardous Waste event happening in Elma at the DPW garage, from 8:30am to 1pm. There are still reservations available for the event, you do need to call to make a reservations, accepting all types of batteries, paints, and information is on our website.

Trustee Hamernik: Wanted to say thank you for all the well wishes received and will be in Phoenix July 10 accepting her award.

Deputy Mayor Adolf: It's summertime, a lot of people are out and about, just ask residents to be cognizant of kids and people walking their dogs, so look twice before you make a move.

### **PUBLIC COMMENTS AND CONCERNS: -**

Elizabeth Brinkworth, Assemblymember Monica Wallace's Office: Their office hosted their annual Women of Distinction Awards Ceremony last Friday, able to highlight various women and their accomplishments throughout the district. A couple from Depew, Depew Police Department Lieutenant Rochelle Menard, PATH Director Julie Palmer, Depew Fire Department Captain Dawn Gauthier, and Fantastic Friends President Debbie Cordone. Summer Reading Challenge is back – encouraging kids to read at least 15 minutes a day for 40 days in July and August. There are Summer Reading Challenges at the following locations: Lancaster Public Library, Anna Reinstein Memorial Library, Julia Boyer Reinstein Library, Lancaster Youth Bureau, Alexander Community Center. Those can be picked up, a booklet that they get to mark off the days they read, if they complete the program, they mail back the packet to their office and get a certificate for all their hard work. Assembleymember Wallace announced last week that she was able to secure \$30,000 for the Depew/Lancaster Boys & Girls Club and this was to purchase several games like skee ball, bubble hockey, arcade basketball, an interactive white board, claw machine, X-box. In terms of legislation, the Member was hard at work this session, was able to pass 11 bills in the Assembly, 10 of which got passed in the Senate, hoping that those that passed in both will be signed into law. Wanted to highlight is on that is important to the Assemblymember and Senator Gallivan, it is Assembly bill 3052, also known as the Trooper Lakeman Bill, which essentially allows for his application that was filed with NYS Local Police and Fire Retirement System to be filled in a timely manner.

Nancy Sirianni, 91 Candance: Had concerns about Carrubba's Chicken Pit, her backyard butts up to them. Has two pods on lot that hasn't moved, wondering if they needed permits. Also, sometimes the dumpsters are left open.

Don Bielefeld, Code Enforcement Officer: Explained that Carrubba's had filed for permits for outdoor storage buildings but the company took their money and ran. They have since filed for new permits, which were approved, once they are in place, that stuff should move.
