#### <u>**DEPARTMENT HEAD REPORTS – November 2023 - Police**</u>

#### **PUBLIC COMMENTS:**

Kate Zaganiaczyk: Wished everyone Happy Holidays, Make sure you take care of driveways and sidewalks when the snow starts flying, renewal notices for plumber licenses have gone out, if interested in obtaining one from the Village contact the Building Department or the application is available online.

Chief Miller, Police Department: thanked Board for hiring these four candidates, it will have a huge impact on the department for years to come. November 2023 report, we responded to 11970 calls for service, in November we had 965 complaints, 855 non-criminal, 110 criminal, we had two stolen automobiles, we recovered one, 47 property accidents, we arrested 21 males and 14 females, and issued 181 summons. Reminder to lock your cars and take your keys, a lot of stolen cars are because of key fobs left in the car and have a nice, safe holiday season.

Chief Gauthier, Fire Department: I'd like to congratulate the newly elected Chiefs: Brian, Joey and John. Congratulations to all of you. I'd like to thank our Fire Department and the Village for the opportunity to serve in this position for the last year and eight months, I do appreciate it. For the month of November, 6 calls, year to date 361. Winter time is coming, make sure if you have a wood stove that the chimney is clean, be smart if you are burning wood in your house and also carbon monoxide detectors have a 5-year life expectancy, so if you have had one for a while, within 5-7years that detector should be replaced.

Kevin Ferguson, Recreation: Rink is going real good -30 in this learn to skate class, about 40 for open skate on Saturday and Sunday, and if you go by the park, the Pavilion and Gazebo are well lit and they look nice.

Ken Pyc, DPW Superintendent: Still picking up leaves for the next couple of weeks, weather permitting and all our plows and salters are ready to go, hopefully we don't need them.

Trustee Ziemba: Fire Chief Gauthier, thank you for everything you did to keep our residents safe, to our new recruits, good luck in the Academy, try to be safe in the Academy and when you graduate, try and keep our residents safe.

Trustee Hamernik: Happy Holidays to all! Congratulations to our new Chiefs, I know they are going to do a great job. I want to say that our Village, between our Police Department and our Fire Department are the best and welcome to our new Officers.

Deputy Mayor Adolf: Chief, Congratulations on your term, it was well served and we appreciate everything you did for us, welcome to the new Fire Chiefs! Justin, Michael, Jacob, Alex, welcome – you'll see how collaborative this Village really is – the Departments, everyone pulls their weight and really works as a team, so we are excited to have you on board and bring you along and have you contribute to the collaboration we have here. It's what makes this Village so great, so welcome, congratulations, Happy Holidays, Merry Christmas, Happy Hanukkah.

Mayor Peterson: Thanked Chief Gauthier for his time as an Assistant Chief and Chief and appreciate his efforts and service to the Fire Department. I just wanted to thank everyone who helped out, donated toys for our first Toys for Tots campaign. I came in a distant second to my brother – he had like 62 boxes of toys in the Albany area. We had more like nine or ten, but it was still a great start , we learned some things and being a first time participant with the US Marine Corps, they started us with two boxes, we actually got four towards the end. Great to have Audrey back – this past Thursday she was honored by Legislator Todaro as Citizen of the Month at the Legislature, big kudos for that, congratulations!

Brian Musielak, 46 Stewart Drive: Want to start off by thanking Chief Gauthier for his years as Assistant Chief and as department Chief. It was a pleasure working with him for my four years as an assistant, I think we got a lot accomplished and laid some good groundwork for the future. Secondly, I'd like to congratulate my Assistant Chiefs: Joseph Aquino, First Assistant and John Hughey, Second Assistant. I'm going to count on them a lot and ask for their support and cooperation, I know I'll get from them and I think we have a lot of great things on the horizon, like I said, a lot of groundwork has been made over the past few years between Past Chief Todd Rzeszutek and Chief Gauthier and I look forward to working with the Village Board, Mayor Peterson, Administrator Grzankowski, and all the other department heads and of course, membership in our Fire Department. Questioned the passing of the E-Bike/Scooter Law and whether there had to be a warning signal like a bell or whistle? Asked Trustee Hamernik if the fire hydrant snow removal program was going to continue. Questioned about the replacement of the bridge on Marrano Drive. Merry Christmas to everybody and Happy Hanukkah and Kwanza.

Joseph Milazzo, 479 Lein Rd: Happy Holidays and Thank you. He is building two homes on Rossiter Ave, and looking for a permanent no parking sign right on the corner by the stop sign, trying to get equipment in the driveway where the buildings are going to be built, and access for Fire equipment. The problem is blocking the driveway and the Police cannot enforce anyone to move their car – no access to his lots and it's a concern for safety as well. It's the way the street is being developed. Was told to send a request to Chief Miller for them to investigate the request for the no parking sign. Village Attorney Alba asked if it was an active construction sight or if there was a curb cut – mentioned that remembered this project from Planning Board, need to make sure that any disputes

between him and the surrounding neighbors remain with him – the Village can only do so much.
