#### **DEPARTMENT HEAD REPORTS –**

CEO Bielelefeld announced that he is very happy to have new Assistant Code Officer, Craig Blanchard, on board. They were already making progress on his first day, which was today.

Mayor Peterson asked Craig to say a few words to introduce himself: Craig thanked the board for the opportunity and said he is looking forward to get started here and to work with Don. He has been in construction and he came to us from Lancaster. He has a 7 month old daughter at home and it is great coming home to her every day and being able to spend time with her.

#### Chief Miller -

Our department and our officers are doing a great job.

The safety of the public is our highest priority and we are committed to ensuring all our residents feel safe in this village. Please keep all our officers in your prayers as they continue to keep this community safe.

The Chief from Cheektowaga PD, Lancaster PD and I had an opportunity to meet with assembly member Wallace last week and we discussed criminal justice reform and how it affects our communities — she was very receptive to our concerns, we discussed the State Chiefs legislative proposal and how our departments and our community have been affected by criminal justice reforms. So, I thank her for giving us her time to discuss these important issues.

We continue to review and update all our department policies and procedures to assure that we applying best practices throughout our organization.

We continue to modernize this department and improving our officers through training and professional development

And as always - I want to thank the public for their support and encourage anyone to call us if they think they have been a victim of a crime or observes something strange. We are here to help and we can't do that if you don't call us to make us aware of a problem

Please remember to lock your cars and secure valuables. Don't leave your vehicle running unattended and never leave your keys in your car.

Attorney Alba did not have much from legal but said the search and survey on the property on Sanilac will hopefully be completed soon as Joe Keefe is working on it for the Village. The Village received a few FOIL requests but they were pretty standard.

Rec Director Ferguson reported that there is about 6 weeks left at the rink. Regals are on the ice 7 days a week. Some teams that are no longer in playoffs, etc need the ice. He is going to begin selling blocks of their unused ice time to people who wish to have birthday parties there. It will be \$200 per hour with free skate rentals. Summer activities are lined up as well, basketball, softball, kickball, etc. He will also have floor hockey in the rink once it's cleaned up.

Superintendent of Public Works said the guys are working on cutting trees, salting when needed and also working on finishing up the work in the Code department.

Trustee Ziemba asked everyone to keep the people of Ukraine in your thoughts!

Trustee Kucewicz Thanked Deputy Mayor Erica for her years of work on the board and she wishes her all the luck in everything going forward. She also welcomed new Ass't CEO Craig and newly appointed Trustee Andrew Adolf, and told him she looks forward to working with him.

Trustee Hamernik thanked Erica as well and told her she has enjoyed working with her for the last 3 years. She thanked her for all of her work she's done over the years like getting the Tree Board up and running! She thanked the Fire Department for coming to do a walk through at the community center. Told everyone we should be very proud of our department, they have 14 people just recruited! Great Job!!!!!

#### Trustee Hamernik also read a statement:

She is honored to accept the position of Deputy Mayor! She wanted to thank the Mayor for the opportunity to serve as Deputy Mayor. She said they all have a roll to play in building a better tomorrow for our community and she promises to continue the progress that is being make in the Village!

Mayor Peterson told Erica that he first remembers working with her on the Tax Reform party in 2017, then running together when he, Ed and she ran for office together. He thanked her for her all 3 years of efforts!

1<sup>st</sup> Assistant Fire Chief Gauthier explained that the training the fire department just completed from the NYS Chief's Association was fantastic. A total of 44 firemen were there to complete the training. A lot goes into planning for this type of training. They may look to use another facility next year, that isn't certain, but they will look into it. It has to have a lot of amenities for all people who take the training. He did the training himself and even with all the years in the department, he got a lot out of it. This type of a course can help firemen stay safe and importantly, help them to help the community and save lives.

Mayor Peterson read a few communications that he received that do not usually get the press that they deserve:

On 2/7 a dog had been hit around 6pm and Officer Canna was on duty. He was able to get to the scene and waited until the owner showed up to get the animal to a hospital for treatment.

On 2/3, an EMS call came in from a daughter who was concerned about checking on her mother, Office Keib arrived and was able to make a forced entry in order for her to get in because she did not have a key to the home. When the responders were en-route, he shoveled a path for them to make an easier entrance into the home.

Mayor Peter ended the meeting by asking everyone to keep everything going on overseas in their thoughts. It's very sad to see this happen and people be injured. He hopes that the situation is resolved rather quickly to end the loss of life there.
