AUTHORIZE MAYOR TO SIGN ERIE COUNTY SNOW REMOVAL CONTRACT

DEPARTMENT HEAD REPORTS –

Liz Brinkworth was in attendance and gave a report on Assembly Member Monica Wallace’s latest activities:

Assemblymember Monica Wallace is back in the district following the end of a very busy session.

Assemblymember Monica Wallace passed 7 bills of her bills this session in the Assembly.

- A744 – requires health clubs with a membership of 50 or more to have at least 1 automated external defibrillator on the premises which is accessible to the staff, members and guests.
- A811-A – allows for the use of green lights or alternating green and amber lights on municipal vehicles being used for snow removal.
- A7489 – related to victim compensation for unlawful surveillance crimes.
- A8880 – establishes a statewide advanced care planning campaign to promote public awareness of hospice and palliative care services
- A8881 – establishes the office of hospice and palliative care access and quality
- A9154 – relates to contracts awarded by the Erie County Water Authority. Purpose of this bill would raise the threshold for which the ECWA must invite sealed bids or proposals for construction-related projects and for equipment, material and supplies.
- A6716-A – establishes the crimes of making a threat of mass harm and aggravated threat of mass harm

-Assemblymember Monica Wallace attend the Moms Demand Actions and March for Our Lives community event this weekend in Buffalo. One of her bills was part of the gun package – A6716-A.

-On Friday, Assemblymember Monica Wallace visited Bellevue Fire District to see the ATVs, SCBAs and computers the fire district were able to purchase with the \$75,000 of state funding she was able to get Bellevue.

-On June 5th Assemblymember Monica Wallace attended the Pride Parade.

-On June 2, Assemblymember Monica Wallace passed a resolution urging federal lawmakers to reinstate the ban on assault weapons and high-capacity magazines.

-Assemblymember Monica Wallace is looking forward to participating in the numerous community events that are occurring across the district.

Police Department -

Our department and our officers continue to do a great job and continue to work hard to keep this community safe.

We continue to participate in the Police Traffic safety grant – targeting aggressive driving and we will be primarily targeting operators that are speeding in the school zones.

Monthly report numbers

Just a reminder - please remember to lock your cars, take your keys, and remove your valuables.

Also with summer upon us – keep an eye out for pedestrians, bicycles and motorcycles – slow down and drive safe

Code Department – Don explained that it is grass cutting time and a lot of violations went out for grass that had not been cut. They are very busy now with construction season for both residential and businesses throughout the Village and asked that the residents be patient.

DPW – Ken reported that they had already purchased two green lights for their plows. The All Inclusive Dawson Park is just about completed, maybe 2 more weeks. The fitness pad has been dug up and stone is next. Then the department will move on to Fireman's Park where they will be preparing another volleyball court. After that, they will address the long shed demolition.

Mayor Peterson explained that when residents here that the DPW crew is working, people immediately think of grass cutting, trimming, repairing lawns, tree cutting, etc. But we really have a lot of talented people in our DPW!! West Dawson Park for example, Jeff Morgan and his crew did a tremendous job on that project, all of the projects that are on-going at Fireman's Park, just to name a few!!! This all shows when we ask them to work on special projects.

Chief Gauthier - 10 calls so far for the month of June
138 calls year to date.

After cutting your grass, do not just put your mower in a shed or garage, keep your lawn equipment 10 to 15 feet away from any structure until it Cools down.

If you have battery power lawn equipment monitor your charging and unplug chargers when battery is charged. There has been several fires nationally due to battery charging.

Attorney Alba reported that almost all of our tax litigations have been completed, with maybe only two left which are a later date tax reduction. We should have our lease to the lower part of the Solar location shortly. He is presenting a legal education class on Red Flag laws and everyone is welcome. It is not solely for lawyers. It is a very interesting program and we ourselves have used it in the past to help save people who are thinking of harming themselves or others.

Administrator Wachowiak stated that the room that was driven into is making progress. The window will take the longest to come in, so a make shift system will be installed until it arrives. The outside stone has been replaced, it is not an exact match, since the building is so old, but it looks real nice. Next will be working on the inside of the room, the HVAC and electrical work.

Trustee Kucewicz thanked Margie for her years of service to the Village. She congratulated our newly and returning employees, Pat, John, Ken. She gave her opinion of the outcome of the newly painted swimming pool and it looks fantastic! She will be working with Marie at our Rec. Department on the pool passes for the summer.

Trustee Adolf wished all Dads, Step-Dads, Father figures a very happy Father's Day!!!

Trustee Ziemba also wished them the same, hoping they can enjoy their day.

Trustee Hamernik accepted another \$2,000 donation to their new community center. The Kitchen is almost and next is to fill in the bowling alley area. On June 23rd at 3pm she will be at a presentation for small business and home business locations to attend to learn about funding opportunities, if you know of anyone who could stand to benefit, please pass the information along.

Mayor Peterson told everyone that we are very eagerly awaiting our Employee Award dinner where employees will be honored for their work at the Village. There will also be a short program to recognize them at the Founders Day kick off on Friday the 22nd of July. The dinner will be catered by Smokin' Little Diner and tickets will be available in his secretary's office. Our Concert Series begins on Thursday the 30th and goes through August 18th. We have gotten great support for these events!!!

PUBLIC COMMENTS OR CONCERNS –

Paul Sprada, 58 Argus told the board that our Thursday Concert Series also coincides with the Cruise Night's at the Polish Falcon's. But he doesn't think that had too much of an effect on us. The Polish Falcons is having a Polka Party in honor of Ronnie Dombrowski tomorrow. There will be an inaugural Town Band Concert where they will service refreshments. It is a wonderful event to take a lawn chair to, enjoy a refreshment and just listen to music and relax. They are going to have some vendors there as well.
