DEPARTMENT HEAD REPORTS - Police June 2021

Fire Chief's Report Village Board Meeting July 12, 2021

- 1) Current Roster: 118 Firefighters, 6 Junior Firefighters
- 2) July 2021 Calls to Date: 12 YTD Calls: 153
- 3) 3) YTD Damages: \$213,000

- 4) Our crews continue to train hard every week, and we are using local training facilities from the county and local departments to accomplish our training needs. I want to thank every firefighter under my command for their continued dedication to the fire department and to the residents of the Village. As I often say, we don't train until we get it right. We train until we can't get it wrong.
- 5) 5) The evening of July 4th was a busy time for us. We had two residences within 200ft of each other that improperly disposed of the remnants of illegal fireworks into their garbage totes, causing them to start on fire. One of the residences had the garbage tote start their attached garage on fire. Thanks to the quick response of a neighbor, who called 911 immediately to report the incident, we were able to respond quickly and knock the fire down. At that time of notification, we were just a few houses down extinguishing another garbage can that also ignited for the same reason. Thankfully, there was no extension to that house. In addition, during these two calls, the fire department was dispatched as mutual aid to a structure fire in the Village of Lancaster. Depew crews were on scene quickly, and assisted Lancaster with fire operations and water supply.
- 6) 6) Early Sunday morning around 2am, the Depew Fire Department was dispatched to a reported structure fire on Main Street. The fire building had multiple families living in multiple apartments. All residents were able to get out of the structure, and no injuries were reported. I want to thank my personnel, along with our mutual aid partners (Lancaster, Bowmansville, and Twin District) for their quick response. Fire personnel on scene had the fire under control in a short amount of time, preventing further fire spread throughout the structure

DEPEW POLICE REPORT

New Hires:

Travis Small – Travis had great experience and comes to us fully trained. We fully expect it will take approximately 1 month of FTO (Field Training Officer) for him to understand our procedures but will have an immediate factor on staffing needs. Travis has two years' experience as a Marshal with the Seneca Nation, two years with the Village of Gowanda Police Dept. and two years with the Village of Blasdell. In the past two years Travis was a part time officer with both village agencies, often changing uniforms from one shift to the next. He moved to Depew four months ago with the hope of getting a full-time position.

Marcellus Jones – Marcellus also has great experience as a Police Officer. Marcellus was a Police Officer with the Chesterfield County Police in Virginia for five years. He grew up in the area and attended Lancaster High School and returned to the area in 2019. He will need to attend the Police Academy, but his previous experience will allow us to reduce the necessary FTO time.

The administration is continuing to work on our new policy manual, we've begun releasing new policies for our members to read and acknowledge. Our officers are giving extra attention to areas where residents have had traffic concerns (speeding vehicles, vehicles disregarding stop signs).

I'd like to thank the members of the Department for their continued dedication and commitment to keeping the residents of Depew safe. Please keep all first responders and public servants in your prayers as they continue to serve their community.

DPW REPORT

DPW will be starting our first phase of milling and paving streets this Wednesday or Thursday (July 14 or 15)

We hope to have the streets paved as soon as possible after the milling process. As always, we are asking residents for their patience through this process, especially when paving is being done. The less traffic on the street that day, the better.

Again., we will be working with the Town and Village of Lancaster through the shared services agreement.

Mayor Peterson read a commendation letter from a resident who wanted to express her gratitude to two fine men in the DPW for their efforts in taking care of a neighboring, abandoned property. While on a slant, in water and on a hot day they never stopped until the work was done. So she wanted to say thank you to Kyle Bicknell and Dan Wypij!!!!

Bob Brandon of Senator Kennedy's office explained the new traffic law that the Senator worked on. For those that qualify, if they receive a minor infraction and cannot pay their fines, the new law allows people to apply for permission to make payments on their fine in order to keep their license active and not suspended. The cost is \$25 or 2% of their net income, whichever is lower. Again, people must apply for and be approved for this option. The Senator was also able to secure \$500,000 for health crisis services. During the trying time of the Pandemic, stress, anxiety and depression have increased dramatically and the operations of health crisis services is in need of this funding to help support their efforts. He was also able to secure \$1,000,000 for sewer infrastructure to Municipalities who are currently under a consent order.

Liz Brinkworth, for Councilwoman Wallace stated that for those businesses that did not qualify for loans during the Pandemic, please call the office, the staff is in and ready to answer calls and to try and help them in any way they can.

Rec Dep't – Yoga is going strong, 40-50 people at each session. It is so popular that they will add Monday as another day for the program. Pool is open and family and single passes for residents is going very well. There is lacrosse and softball almost every day. The park is busy with a lot of activity and it's just great to see!!!! Ice sales for the fall are almost all sold out.

OEM – just working on action plans for the upcoming events each week. Mayor Peterson thanked RJ and Galen for the enormity of hours they spent during the onset of the pandemic. They were obviously dedicated because their positions earn no salary. So thank you both!!

Attorney Alba told everyone that on 6/21 another paper street sale closed and we are just waiting on Sanilac Street which should be any day now!!! The new animal law will be ready for the next meeting he is hopeful for.

Code Enforcement – The Village is excited to see new businesses opening in the area. Many are big projects and they are close to being open!!! Also, the Village was awarded a grant for Archiving!!!! This is fantastic news!!!

Administrator gave an update on the building renovations. The roof is approximately 98% complete and HVAC work is probably at 75% completion. Windows will be the final phase of the borrowing on this BAN and should begin by the end of July or early August.

Trustee Ziemba thanked the Village's two new police officers for stepping during these times when not many people are willing to work in this field! Thank you!

Trustee Hamernik reported that approximately 120 families were fed over the weekend.

Deputy Mayor Stempniak wanted to give a shout out to the Recreation Department. While walking through Fireman’s Park, it’s obvious the buildings have all been painted. Great job to Director Kevin Ferguson and his Team.

Paul Sprada, 58 Argus wanted to clarify what he thought Attorney Alba said about the new refuse service having a electronic recycling day collection. Mayor Peterson corrected him and said that no, there will not be a regular collection of electronics in the Village. However, in the fall, one will be scheduled as a general “drop off” where Village Residents only, will be able to bring their electronics to recycle them. The date and time, along with location, has yet to be determined.
