At one point in March, we had 3-part timers and 1 Full Timer. The two guys we hired in January were excellently qualified.

#### **DEPARTMENT HEAD REPORTS -**

Emergency Manager – RJ – Mask mandates are back as of 11-23-2021. He will ask the departments if they need gloves, masks and wipes. You need to wear your mask even if vaccinated. There are no gathering rules yet or having to show proof of vaccine for restaurants. State of Emergency has been declared for the Village of Depew. We will be looking to have a 6 month supply on hand. Thank you to Mayor Peterson and the Village Board for the grant allotment for the radios that we will be receiving. We are waiting for them to come in. We will be working with Regina for the tree lighting and writing the Action Plan for that. An email will be going out the department heads for the annual winter storm meeting.

Depew Police Dept – Every patrol officer has been issues a body camera. They are being used on a daily basis. We had a major incident over the weekend. Without giving out a lot of details, our officers acted very professional. They arrived at a very violent scene, their training and experience took over. I am very proud of their efforts and they were able to apprehend the suspect pretty quickly. We had assistance from Amherst PD, Cheektowaga and Lancaster. The cooperation we had a group was awesome and on scene we had our two pastors, Pastor Brian and Pastor Galen Purpura to help the guys deal with the stress of this call. Thank you.

DPW – Ken – Plows and salters are ready. The parking ban has been extended until December 1<sup>st</sup>. Please do not call when you are raking your leaves, we will be around to get them. Do not put them in the streets.

Depew Fire Dept – Chief Todd R. – Currently 112 Firefighters, 6 Junior Firefighters. November 2021 calls to date are at 17. Our year-to-date calls are 293. Year to date structural damage is 545,000. The Depew Fire Dept continues to work hard day in and day out responding to calls and dedicating their time to training. The fire dept will continue to remain ready to any calls that we are called too and will continue to respond with professionalism. I want to offer my sincere gratitude to my firefighters, officers, and my command staff for their continued dedication to the Village of Depew and the residents that we serve. An issue at the end of last week with Ladder 5, it is currently out of service and will be for the foreseeable future. The truck was on its way back last week from getting some electrical work done and the radiator blew, it was found to have a crack in the top corner and it will need a full replacement. Colden Enterprises, who maintains our fleet currently has our truck. They are looking at the possibly of a used after market radiator, if this works then we are looking at a \$5,000 - \$6,000 bill. If not, a new replacement will be \$15,000+ for ladder 5 and until that is done our ladder truck is out of service. We do have mutual aid agreements in place if need be. I was going to also report that Engine #6 is out of service, but from the pre board meeting until now, it's fixed. That's again to Colden who came out. I mentioned this last month and I want to mention it again, it's very serious, all residents are reminded to have working carbon monoxide detectors and smoke detector in your homes and apartments as the weather is getting colder our furnace's and boilers and firing up for the first time and this is the time of year that the majority of the issues arise. Carbon monoxide gas is deadly as it is colorless and odorless, meaning you can't smell, taste or detect it any other way. Smoke detectors forewarn occupants in a structure. Issue with sewer system at The North Side, we are looking to Pipeworks to have the rectified for us.

Trustee Ziemba – Happy Thanksgiving. DEC – Styrofoam ban is starting January 1, 2022. The information is on the DEC website. We will get it on the Village website. It will be phased in, probably will not see the full effect for another year.

Trustee Hamernik – Happy Thanksgiving. On behalf of being a Trustee for the Village of Depew I have delivered Fresh turkeys with fixings. I will deliver prepared dinners tomorrow (Tuesday 11/23/2021). They are going to the residents over in the Main St & Penora St. area. They were donated by Kiwanis Club and some residents. Community Center update – a Depew business donated 3 furnaces along with the labor to our building. We are thankful for that. Businesses in Depew, Lancaster and Cheektowaga have donated over \$100,000 to our community center. We just received notice from Legislature Frank Todaro that we were awarded \$15,000 for our community center.

Thank you to him. I started this about 5 months ago, I formed an alliance Tri Community Food Pantry, called Tri Com Delivers. We started with five families. We deliver food every 2<sup>nd</sup> and 4<sup>th</sup> Tuesday of the month. These are disabled residents who would not be able to make it to the food pantry. We are working on expanding the program.

Trustee Kucewicz – I want to thank Tony, who is not here today, for his long service with the Village of Depew and wish him the best in his next adventure. He will be missed. Happy Thanksgiving.

Deputy Mayor Stempniak – Davey Resource Group is out doing the tree inventory. Please do not call to report suspicious persons. We know they are out there. Thank you to Assembly Member Wallace for looking into the daycare situation in NYS. I am fortunate to be able to pay for daycare while being a working mom, but that is not the case for many families. I am very happy this is being examined, something needs to be done so more women are able to enter the workforce. Happy Thanksgiving and GO Bills.

Legal – We are not too busy this week. Going through a few contracts and checking into a few things. Tried to discouraged Asst. Code Enforcement Fischione from resigning, but it didn't seem to work. The big project in next couple weeks we will soliciting shared services agreement for a code enforcement officer for the building department. Mr. Brandon or Ms. Brinkworth if you know of any building departments that don't have enough work, we would love to talk to them. While we are looking to fill the position, we will be happy to enter into a shared service with someone just so there is no shortage. Nothing on the litigation front and that is always good.

Mayor Peterson – Annual Tree Lighting will be Monday November 29, 2021 at Fireman's Park. Santa will be with us. Our long time Village Santa Jeff Schuler will not be doing it this year. Mr. Schuler stated this would have been his 50t year playing Santa, but is not able to because of his heart. It should be good for next year, which will be my final year. I am writing a book "What it takes to be Santa". It will be out in 2023 and will have a big party at The ELKS for my customers and the Village people. I will have a big parade to the party from the mayor. Jim Kelly will be there because I know his kids. I am not taking any money; this is my way of saying Thank you for all I have done and I have done a lot. The Village knows, the book is coming out so the people of the United States can see when I have done. It's not about me, it's about the kids. Jim Kelly is having it published for me. I am praying in 2025 when we do the Radiothon for Make a Wish. I am keeping one suit, I have three. I told the Mayor that I will let the gentlemen that is playing Santa this year, they can use it. I have no problem with it. When they do the Radiothon, when they do the total, I am walking in as Santa one last time and matching the total so every kid gets his wish. It's all about the kids. I have had a great ride, I cannot complain. I am going to miss it this year. I am helping the Santa out this year. I have some customers if wants to do it. Last year was a great time going around the Village. Next year I am not going to have anything else planned except the Village. I have had 45 years at the Buffalo Airport welcoming home the troops. I got to fly with The Blue Angels. I just want to say Thank you. Mayor Peterson stated there will be Mrs. Clause and firepits for roasting marshmallows supervised by the Depew Fire Dept.

#### **PUBLIC COMMENTS OR CONCERNS**

Bob Brandon - Senator Kennedy's office – Thank you for having me again. Our office organized and participated in turkey give away's in two areas of our district. Last Wednesday we were at Tops Markets on Jefferson Avenue and gave away 750 turkeys. Last Saturday we were at the Lackawanna Senior Center where we gave away 250 turkeys and grocery gift certificates. I personally delivered 21 to mostly immigrant families so they could have a Thanksgiving dinner. A driver from NFTA brought a van with him. The Senator had his monthly radio show and had representatives from HEAP (Home Energy Assistance Program) as far as who qualifies and how to get utility bill funding. National Fuel was one discussing the payment plan options. Partial payments are acceptable. The Senators radio program is always the 3<sup>rd</sup> Sunday of the month on WUFO. The Senator is Chairman of the State Transportation Committee and he stated that more than 1,700 bridges, 7,300 miles of highways and local roads, as well as the states passenger and commercial railroads are in poor condition, money from the 2.1 trilliondollar Infrastructure bill that President Biden signed last week will go a long way to repairing them. He mentioned that the money from the infrastructure bill could also be used for water supply, replacing lead pipes, modernize the power the power grid and

expand speedy internet access. Check out the Cheektowaga Bee for more information regarding the infrastructure bill. Happy Thanksgiving from Senator Kennedy and myself. Mayor Peterson - that when the infrastructure bill was first being discussed it was approached to me that the Transit Road bridges and the work that would need to be done to widen Transit Road. It was explained to me that Delaware Ave project through the park was a big deal and so was the Skyway. Bob stated that the 33, they would like to cover it. Mayor Peterson stated with the changes with the Skyway, maybe there is some money to widen that bottleneck that comes from the North down Transit through Depew and Lancaster. The agencies will have leeway as to how to spend the money. They set the priorities and that is where the money is spent.

Liz Brinkworth – Assembly Member Monica Wallace's Office – Toured a child care center with Senator Brisport and Assembly Member Hevesi as part of their statewide education collation task force, to see how we can assist on a state wide level for child care. There are over 3 million women nationwide not in the work force due child care issues so we are looking at ways to help. They toured Little Angels Day Care in the Town of Cheektowaga and met with staff and the owner. Thanked the Governor for signing a legislation that Monica Wallace sponsored to create a committee to represent female veterans with their own committee. This would give female veterans programs and services that meet their needs. December 4, 2021 Member Wallace is hosting an erecycling event, there are 100 slots left. Apply online. Getting word out about the NYS Troopers exam, for more information go to joinstatepolice.ny.gov. The exam is open mid-January until April 2022. Happy Thanksgiving.
