Mayor Peterson let the residents know that the Village Offices are open for business. Residents can call and make an appointment, speak to the employees and get the information they need.

A resident inquired as to any updates regarding George Urban Blvd Grant Improvements. The Mayor stated that he is waiting to hear on the grants that were applied for. As soon as the Village hears something, we will inform the public.

Ms. Miller asked what streets the CDBG sidewalk grant will cover this year. The answer is Terrace, Warsaw and Argus and that part of that money from Cheektowaga CDBG goes to help fund the Senior Center as well.

Another resident asked if the Village was entertaining a community garden. Trustee Hamernik stated that part of the plans for the new community center was to have one on one side of the building.
